- The next page will ask you to upload two types of evidence electronically, this includes property details such as rent or mortgage statements, utility bills, insurance documents, or financial documents like bank statements. Note that this will need to uploaded digitally.
- You will then be prompted for bank details to where the payment should be made.

- If you have multiple eligible properties, you then add a new one following the same process as above.
